- *September 1, 2006 – incorporated*
- *September 22, 2006 – organizational meeting, bylaws adopted*
- *June 17, 2007 – application for tax-exempt status approved by the IRS*

Description

- *The purposes of the Iowa State Association of Counties Education Foundation, Inc., are exclusively educational and charitable, in compliance with I.R.C. § 501(c)(3) and Iowa Code chapter 504.*
- *The ISAC Education Foundation will promote the scholarship program of the Iowa State Association of Counties and conduct fundraising events in support thereof.*
- *The ISAC Education Foundation was incorporated by Bill Peterson, David Vestal, Linda Hinton and Jay Syverson.*
- *The ISAC Education Foundation's initial board of directors included ISAC Executive Director Bill Peterson and the members of the ISAC Executive Committee at the time of incorporation. They included:*
 - *Denise Dolan, Dubuque County Auditor (ISAC President)*
 - *Kim Painter, Johnson County Recorder (ISAC 1st Vice President)*
 - *Mike King, Union County Supervisor (ISAC 2nd Vice President)*
 - *Gary Anderson, Appanoose County Sheriff (ISAC 3rd Vice President)*
 - *Angela Connolly, Polk County Supervisor (ISAC Immediate Past President)*
- *Beyond the initial directors, the ISAC Education Foundation's board will include between 4 and 20 members to be appointed by the ISAC board. (ISAC Education Foundation board members will serve a term of one year or until a successor is appointed.)*
- *The officers of the ISAC Education Foundation will be the president, 1st vice president and 2nd vice president of ISAC, who will serve the same roles for the ISAC Education Foundation.*
