


# The Important Role of the County Recorder In Iowa

- The office of the county recorder was created by the first Legislative Assembly of the Territory of Iowa in 1839.
- The basic duty of the county recorder was to maintain official records of documents affecting title to real estate in order to preserve property rights and protect innocent third parties in real estate transactions.
- Since, 1839, the Recorder has acquired more responsibilities such as Registrar of Vital Records, Passport Agent and issuer of recreational vehicle registrations and hunting and fishing licenses.

### Recorder's role - past, present and future

The cornerstone of the Iowan economic system.

- Every parcel, building, and piece of property in our county is represented in a document that has been recorded in our office; we protect and preserve those documents for future generations.
- These documents are a visible sign of a massive behind-the-scenes process that is foundational to the economy.
- The Recorder's responsibility is to preserve property rights and protect innocent third parties in real estate transactions.
- The less-efficient the Office of the Recorder is, the more expensive it is to the homeowners and stakeholders of our county.

### Recorders have a business to run



### Recorders have a business to run

- ... where everyone in the county is a customer and a shareholder.

County Recorders have great relationships with the offices they partner with and can get answers almost immediately for constituents who rely on them. For taxpayers, that is a direct line of communication between themselves and their state offices. If we don't get our job done, the rest of the industry is affected. We have internal customers who depend on us to complete our work before they can do theirs.

### **Archive Specialist**

Some might think of County Recorders as file clerks or librarians, but our responsibilities for record keeping go deeper. We are preservationists and archivists who must adopt new technologies to maintain and sometimes convert information to formats which are accessible to businesses and citizens. From paper to microfilm to digitized images, it is imperative that County Recorders preserve vital records and real estate records forever. We value our partnership with the Supervisors as preservation is a joint endeavor.







- .... which is managed in a fiscally responsible manner.




County Recorders process millions of transactions each year in the form of recording fees, transfer taxes, license fees or other payments. Individually most of these retail-like transactions are small. But they add up, and that represents a significant revenue to the county and to state budgets. The revenue generated supports our operations. Many County Recorders across the state accept credit cards ... reducing the risk of check fraud and increasing cash flow for the county and our partner agencies.

### Recorders work daily with 4 State agencies

- Iowa Department of Natural Resources
- Iowa Department of Revenue
- Iowa Department of Health and Human Services
- Iowa Secretary of State.

- Iowa is the leader in the nation in delivering the first and still today, most comprehensive and user-friendly electronic records access and recording in the country. Not a leader but THE Leader!
- We also created a disaster recovery system that all County Recorders can access. By participating in the Iowa Land Records website, county recorders created an additional unaltered version of the electronic documents in their office. This project was funded through legislative action and is user-fee based. That is the kind of ingenuity county recorders bring to county government.


### America's first state-wide e-submission service

### Efficiency Expert

- In calendar year 2021, Iowans filed 56% of their documents electronically,
- Since an electronically filed document takes a fraction of the time to process, the result is net savings to the property taxpayer, by reducing the cost of a person to process those documents.
- Electronic filing increased significantly during the COVID-19 pandemic.




### **Efficiency Expert**


- Recorders are team leaders

### **Privacy Protector**

- County Recorders are the first line of defense against fraud
- ... by monitoring new documents for Social Security Numbers and other personal information.
- ... by redacting personal information for public document images.
- ... by enforcing state laws that restrict access to military and vital records.
- ... by monitoring real estate transactions for suspicious activity.

- By promoting Iowa's outdoor recreational activities, Recorders are directly supporting natural resources and local economies.






