## I. Reports:

a. Financial Report:

Molly Hill reviewed the Balance Sheet and Income Statement. Motion to accept the financial report as presented was made by Boone County, seconded by Linn County. Motion carried unanimously.

Jessica Trobaugh provided the Program report. The first week of July, Jessica pushed out the new charge code, but it was discovered there were some errors with the marijuana charges. The next few months will be focused on moving Johnson County to Karpel.

a. Update on Trial Information Exchange:

We are still working with the Courts on the Trial Information Exchange. Currently the Courts are unable to accept more than one document at a time through the Exchange so this needs to be fixed. Once this is corrected, we will do more beta testing in Karpel followed by beta testing in Prolaw. The new timeline for this to be pushed out to everyone will most likely not be until November or December.

A Juvenile Exchange will be coming and will work similar to the current Complaint Exchange. The difference is that the new exchange will send the County Attorney and the Juvenile Court Services a copy of the juvenile referral from the beginning and will not go to the Courts first. This info will come into your system through the Import Referrals area if using PbK or as a new CJIS case if using Prolaw. Once this Exchange is up and running, we will get this out to everybody.
